The Showmen's Guild of Australasia and the AgShows NSW have agreed that the following items be banned at country agricultural shows as it is our view and aim to protect and attract families:

- \*Explicit And Hardcore T-Shirts
- \*Fuel Type Fire Lighters (Zippo)
- \*Knives (Including Pen Knives)
- \*Water Bombs
- \*Pressure Pak Fart Gas
- \*Fireworks (Crackers)
- \*Silly String
- \*Drug Related Goods (Including Bong, Cocaine Kits)
- \*Fake Cigarettes
- \*Horns and Trumpets
- \*Metal And Wooden Martial Art Nunchucks
- \*Playing Cards (Nude Or Lurid)
- \*Pressure Pak Snow
- \*Stink Bombs
- \*Water Pistols Over 150mm

Toy Guns Are Acceptable, however the following are not:

- \*Pellet Guns
- \*Replica Guns (Bullet Type)
- \*Eight Shot Caps
- \*Samurai Swords
- \*Shanghais
- \*Catapults or similar items or parts thereof
- \*Metal Arrows or Arrows with sharp or metal points
- \*Ball Bearing Guns
- \*Popdowns (Throw Downs)
- \*Strip and Roll Caps
